## Announcement of the cessation of active voluntary work for United Nackenheim on December 31, 2022 by Peter Stey

I will stop my active voluntary work as a provisional moderator and active member of United Nackenheim on December 31, 2022. I plan to continue to be a passive member of United Nackenheim.

- I will stop advising refugees, asylum seekers and citizens of Nackenheim with effect from December 1st, 2022.
- After eight years of active work in refugee care, I will be retiring from this field of voluntary work.

The following members also declare their withdrawal from active refugee work with effect from December 31, 2022:

- Werner Balbach Workshop
- Ingrid Stey search for accommodation, donations and general assistance

All members thank the city government for the good cooperation during the last 8 years. The work will continue until this date, based on the existing decisions of United Nackenheim.

## What does this mean for the people who have been cared for by United Nackenheim so far?

- From December 1, 2022, we will no longer process any new consultation requests. Current processes will be completed by us by December 31, 2022.
- The e-mail user <u>un@nackenheimer.community</u> receives a notice of absence indicating that the support for refugees ended on December 1st, 2022 via this user. In this automatic reply, it is pointed out that the persons concerned should be written to directly. Furthermore, it is pointed out that the e-mails are not processed by this user. All existing e-mails will be deleted by March 1st, 2023 at the latest.
- The powers of attorney granted to United Nackenheim automatically expire on December 31, 2022. This means that we are no longer able to make inquiries to authorities or companies on your behalf or to process ongoing processes.
- Everyone can request a USB stick from us with their data that has accumulated over the years by e-mail or WhatsApp by December 1st, 2022. ( <u>un@nackenheimer.community</u>) This includes the data we have stored, as well as the mail traffic we have. On the USB sticks there are descriptions of where which data is stored.
  - **Note:** your data can only be forwarded to other care centers if they present a power of attorney signed by you. **The data will be deleted from us on March 1st, 2023.**
- The current list of counseling offers for Refugees and immigrants in the district of Mainz-Bingen (2022-07-11 Beratungsangebote Landkreis Mainz-Bingen.pdf) will be published both on the USB stick and on our website. (
   <a href="https://nris.nackenheimer.community">https://nris.nackenheimer.community</a>) This list contains all the advice centers in the Mainz Bingen district that you can turn to if you need help.

- A decision has not yet been made about the website of United Nackenheim ( <a href="https://nris.nackenheimer.community">https://nris.nackenheimer.community</a>). It is planned to maintain this for at least another year.
- The workshop, the furniture exchange and the search for accommodation will no longer be continued by United Nackenheim after December 1, 2022. We are also no longer placing refugees to for work for the local community / city projects.
- The WhatsApp group United Nackenheim and the Facebook group United Nackenheim can continue as long as a new administrator is found. Otherwise they will be deleted on March 1. 2023.
- All financial support (voluntary work allowance for integration guides, travel expenses, support for German courses, book subsidies for trainees, assumption of interpreter costs, subsidies for the purchase of computers, etc.) end on December 31, 2022. The remaining funds managed by United Nackenheim will be transferred back to the local community after the 2022 cash register. (Integration guides' billing or other requests for grants should be submitted by December 15, 2022 latest)
- If the Stey family was involved in renting an apartment, the landlord will be informed when the support has ended.
- The 1. FCN is informed about the dissolution of United Nackenheim. At the moment we are assuming that the football team can continue to train at 1. FCN.
- Publicly accessible records and documents of the working group of the local community of Nackenheim (freely available), remain freely available until the local community has made a decision. (But will be deleted no later than December 31, 2023)
